ORDER:

The District Educational Officer, Vizianagaram has verified the application for provisional recognition to **Fort City School, 100 feet Ring Road, Near Varun Motors, J.N.Puram, Vizianagaram under Sree Balajee Educational Society, Vizianagaram** with reference to the inspection report of the inspecting officer and also with reference to the conditions laid down in the permission already accorded for classes I to VII(EM) as per existing rules.

And also after careful examination of the reference cited and the conditions prescribed in G.O.Ms.No.1 Education, Dt.01.01.1994, G.O. 2nd cited and also subsequent government orders time to time, the competent authority is hereby sanctioned provisional recognition to **Fort City School, 100 feet Ring Road, Near Varun Motors, J.N.Puram, Vizianagaram under Sree Balajee Educational Society, Vizianagaram** for a period of 10(ten) years commencing from the academic year 2016-2017 to 2025-2026 for classes I to VII (English Medium) subject to fulfilment of the following conditions without Grant in Aid.

1. That the Educational Institution should abide by the instructions/rules and regulations made by the Government or authorised officer time to time.
2. That the Educational Institution should observe the needs of the locality more particularly.
3. That the Institutions should adopt the curricula and Syllabus prescribed from time to time.
4. The School timings, vacations and mid-term holidays should be as prescribed by the Government from time to time.
5. That the qualified staff with in the age limits prescribed by the Government employees should be appointed as per the staff pattern and the appointment should be made as per G.O.Ms.No.1 Edn.(PS.2) Dt.01.01.1994.
6. That the results of Institutions should be satisfactory every year.
7. That the list of Governing body should be furnished to the District Educational Officer every year
8. That the records / accounts should be furnished to the District Educational Officer every year by 31st of May of the latest.

That the pay structure/ fee structure fixed by the Governing body should be get approved by the District Educational Officer every year.

That all the conditions prescribed in the G.Os and other orders which are not specified in this order should be complied with.

9. That the school should not be closed without giving notice both to the parents / DISTRICT EDUCATIONAL OFFICER, and competent authority at least 6 months before.
10. That the school should be closed or permitted to be closed only from the date on

13. That the society should submit proposals for renewal of provisional recognition sufficiently in advance i.e. at least 6 months before prior to the date of expiry of this renewal of recognition.
14. The management should constitute the Governing Body as per the rule 15 of G.O.Ms.No.1 Education, Dt.01.01.1994.
15. The Management should provide adequate, Library books, TLM furniture to the school.
16. The Management should observe clean & Green and Implement Govt. Instructions.
17. The Management should replace the unqualified teachers with qualified one.
18. The Endowment Grant should be converted into Joint account in favour of DISTRICT EDUCATIONAL OFFICER and Correspondent.
19. The economic strength should be maintained in every class.
20. That the Institution shall provide fire safety measures in the school as per the No objection certificate from time to time up to the renewal of recognition period ends.
21. That the management is informed that no thatched roof accommodation is allowed to run the school.
22. Proper and adequate sanitation facility shall be provided for students especially for girl students.
23. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
24. The School shall follow traffic and safety guidelines indicated by the Police and fire services departments.
25. The Parent Teachers Associations meeting shall be conducted to sensitize the parents on the satisfaction of their children.
26. The School shall have first aid kit and the teachers shall be trained in first aid.
27. The Correspondent of the school concerned is hereby informed to file an affidavit every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
28. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year.
29. The management is informed to follow the guidelines issued in G.O.Ms.No.91 Edn., dated: 06.08.2009 regarding fee structure in private schools.
30. The School Van/Bus should be ensured road worthy for the transportation/mobility of school children.
31. The management should fulfil all the conditions stipulated in RTE Act.
32. The management should submit the renewal fire NOC every year otherwise the recognition may be withdrawn.



The **Correspondent** has submitted the application for **Renewal of Recognition** for the classes **VI to X (EM)** in the school for the years from **2015-2016 to 2025-2026**. The **District Educational Officer, Vizianagaram** District has verified the application for **Renewal of Recognition** with reference to the Inspection Report of the Inspecting Officer and as per the G.O.Ms.No.1 Education, Dated.01.01.1994. Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada, competent authority for Secondary Schools hereby accords **Renewal of Recognition** for a period of **11 (ELEVEN)** years i.e., for the academic years from **2015-2016 to 2025-2026** for the classes **VI – X (EM)** subject to fulfillment of the following conditions in **Fort City School near Varun Motors, 100 Feet ring road, Jammunarayanapuram Village, Vizianagaram Mandal and District** without Grant In Aid now or in future.

1. That the society shall abide by the instructions / rules and regulations made by the Government or authorized officer from the time to time.
 2. That the Educational Institutions shall serve the needs of the locality more particularly.
 3. The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
 4. That the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
 5. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
 6. That the results of institution shall be satisfactory every year.
 7. That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
 8. That the list of Governing Body shall be furnished to the District Educational Officer every year.
 9. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
 10. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.
 11. That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
 12. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
 13. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
 14. That the society shall provide fire safety measures in the school as per the No Objection Certificate.
 15. The management informed that no thatched roof accommodation is allowed to run the School.
 16. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students.
 17. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
 18. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
 19. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
 20. The school shall have first aid kit and the teachers shall be trained in first aid.
 21. The Correspondent of the concerned school is hereby informed to file an affidavit by April 30th of every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
 22. That the management shall ensure the Accountants of this school audited by an authorized Chartered Accountant every year and submit.
 23. That the management has to maintain trained teachers at all time.
 24. The management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated.06.08.2009 regarding Fee Structure in Private Schools.
 26. That the Management of the school is informed to obtain the Occupancy Clearance from the Fire Services Department concerned for the complete period of recognition now accorded without fail as the present Occupancy Clearance in the Fire NOC.
 27. That the Recognition now granted is subject to genuineness of the Fire No Objection Certificate issued by the Fire Service Department concerned.
 28. That the Management of the school is informed to obtain the Structural Soundness Certificate for the Executive Engineer (R&B) promptly to this office for the without fail.
- If the management fails to comply with the above conditions promptly, the Recognition now granted will be reviewed under the provision contained in GO.Ms.No.730 Edu Dt.29.09.2008.
